- I. Call to order (Singleton) Singleton called the meeting to order at 5:37 p.m.
- II. Approval of the agenda (Singleton) Coronado moved to approve the agenda. Barikhan seconded the motion. The motion passed by consent.

 Greim moved to approve the minutes. Barikhan seconded the motion. The motion passed by consent.
- IV. Approval of April 3, 2023 minutes (Singleton) Barikhan moved the approve the minutes. Gaind seconded the motion. The motion passed by consent.
- V. Executive Committee report (Singleton) Singleton said the committee met on March 13 with Karim. She said it was a follow up meeting to his reinstatement as editor in chief, and all requirements had been met.
- VI. Operations Committee report (Holt) Holt said the committee didn't meet in March because of finals week, but he'd sent out the Doodle to get everyone's availability for spring quarter.
- VII. Finance Committee report (Weiss)

Weiss said the committee met on April 7 and discussed the February financial statements. The details will appear in agenda item X.

- VIII. Media Director's report (Deen) Deen shared the winter quarter newsmagazine posts per week.
 - IX. Public Comment (Singleton) There was no public comment.

New Business/Discussion Items

X. February financial statements (Weiss)

Weiss said that total income was \$147,808 and budgeted income was \$187,416 leaving us <\$39,608> (<21%>) less than budget. Web Media and Outdoor were up 23% and 57% to budget respectively, but Daily Bruin was down 10% to budget. BruinLife studio was budgeted to be open in January, but it will not open until April. Year-to-date income was \$883,703, and budgeted year-to-date income was \$935,411 leaving us <\$51,708> (<6%>) less than budget.

Total expense was \$136,366 and budgeted expense was \$148,962 leaving us \$12,596 (8%) better than budget. Year-to-date expense was \$855,982, and budgeted year-to-date expense was \$964,700 leaving us \$108,718 (11%) better than budget.

Net revenue was a \$11,442 and budgeted net revenue was \$38,454 leaving us <\$27,012> (<70%>) less than budget. Year to date net revenue was \$27,721 and budgeted year to date net revenue was a loss of <\$27,012> leaving us \$57,010 (195%) better than budget. Cash reserves stood at \$776,000 leaving us \$447,000 above policy.

For the March forecast, Daily and Outdoor are projected to be 47% and 49% over budget, respectively, but Web is projected to be below budget 40%
